## 1. Welcome, Introductions, Recognition, and Early Announcements (Melody Tovar/Trish Mulvey)

■ The group recognized Kristy McCumby Hyland's long term leadership and support of the WAMS Subgroup. Kristy served as the WAMS chair for seven years, WMIs longest serving chair person.

# 2. Review Meeting Minutes and Update Action Item from Core Group Meeting on April 3, 2008 (Melody Tovar)

■ The April 3<sup>rd</sup> Meeting Minutes have not yet been finalized. The review and the approval process will take place via e-mail, and then they will be posted to the WMI Website. All April action items were completed.

### 3. EPA Grants (Melody Tovar/Luisa Valiela)

■ Luisa Valiela with the EPA provided a brief overview of the current grant opportunities. The RFP for the San Francisco Bay Area Water Quality Improvement Fund Grant was recently released with proposals due on August 25, 2008. The grant seeks proposals for projects that will restore and protect the water quality, habitat and environment of the San Francisco Bay and its watersheds through comprehensive approaches to water quality management. Awards will range from approximately \$500,000 to \$5,000,000 of federal funds with each project period being three years. Additional questions or clarification should be directed to Luisa.

■ The group posed some specific questions to Luisa about potential project eligibility and selection process. She stated that projects addressing any permit requirements are ineligible, unless your project goes "above and beyond" what is required. Trash control is one of the priorities along with TMDLs. Funding for this grant came from an earmark sponsored by Senator Feinstein. Although this is a one-time earmark it is hoped that additional funding will be available in the future. Submitting proposals now, even if not awarded, will help demonstrate the need for on-going funding.

## 4. Short Term Issue Application – Living Streams Vision Statement (Richard McMurtry)

- Richard McMurtry presented information on the Santa Clara County Creeks Coalition's Living Streams Vision and their efforts to have other organizations and neighborhood groups sign onto the Vision and engage in a letter writing campaign. The Creeks Coalition goal is to conduct up to 350 presentations of the Vision in the next 18 months. The group felt that the WMI could not sign on to the current Vision but encouraged Richard to approach each of the WMI signatories individually, and provided recommendations for other groups that could be approached. Richard was also encouraged to get involved with San Jose's current General Plan update process and will follow-up with Matt Krupp who had specific ideas. Additionally, if Richard is interested in working with the WMI to craft a consensus Vision document, participation in that may be of interest to our SPREF work group; and he can talk with them about such an effort while the next SPREF presentations are being organized
- The Creeks Coalition is considering two other projects: (1) Santa Clara County [?] Friends of the Rivers where volunteers lead guided tours and ask participants to sign letters encouraging restoration of creeks and rivers; and (2) Green Jobs for Youth which would involve at-risk youth in creek clean-up and potentially litter enforcement activities, education on sources of trash and cultural sensitivity training.

### 5. Short Term Issue Applications (Trish Mulvey)

- Invasive Species in Reservoirs and Waterways (Larry Johnann)
  - Larry Johnann provided a presentation on the invasive species impacting our local waterways and concerns about the current inspection program. The two main concerns being: (1) equity of inspection requirements for power boats versus canoes/kayaks, and (2) education and outreach to the boating and canoeing community- especially those who may not be part of organized groups. From the group discussion, Larry was encouraged to work to resolve these issues with the SCVWD and County of Santa Clara, who are responsible for the inspection program. The SCVWD had expressed their interest in working with the Western Canoe Club and other groups prior to the Core Group meeting.

#### Urban Creeks Council Landowner Stewardship Grant Opportunity (Trish Mulvey)

• The Urban Creeks Council is looking for South Bay partners that can provide matching funds to expand the Streamside Management Program for Landowners (SMPL). This program expansion would be included as a component of the San Francisco Estuary Project's grant proposal for San Francisco Bay Area Water Quality Improvement Fund Grant. The Santa Clara Valley Urban Runoff Pollution Prevention Program, SCVWD and GCRCD are considering participation.

#### **6.** Check-in for Subgroups (Melody Tovar)

- Charters for the WMI Product Stewardship and Trash subgroups were reviewed and approved. Roberta Dunlap of San Jose will chair the Product Stewardship Subgroup. Phil Bobel of Palo Alto will chair the Trash Subgroup.
- San Jose is recruiting individuals to participate on its Plant Master Plan Community Advisory Group. Applicants need to live or own a business in the Plant tributary area. Deadline to submit an application is June 20, 2008.
