### Product Stewardship Subgroup

- The group's first project will revolve around pharmaceuticals.
- This group will help bolster current regulations, partnership such as with BAPPG (pharmaceutical take-backs), and more.

### 4. Outside Group Presentations

- Ken Schreiber, Habitat Conservation Plan (HCP) Update (40 minutes)
  - Presenter conducted a PowerPoint (PPT) update on current HCP efforts. (PPT is available upon request.)
  - HCP specifically deals with new developments and protection of species within a
    given area in which construction will take place. The organization only permits
    new activities and does not contract urban-runoff issues.
  - HCP will address some component of erosive forces and will participate in the stream goals effort.
  - The WMI will have an opportunity to comment on the Habitat Plan in March and April 2008. The Public Review session will take place in 2009 from January to March.

- Information on the Strategic Initiatives was presented, but there was no reference to sustainability, but a comprehensive list of items was provided.

- Trish Mulvey expressed concern for the legislation that was presented at the Joint Study Session (i.e., floodplain issues) and would also like the Water District to look into a 50 year plan.
- Would it be feasible to incorporate erosive forces and stream goals into the plan, which will help address the Core Services for the WMI.
- A summary was requested, which would give an overview of the Key Strategic Initiatives.
