No Camping Ordinances



Santa Cruz, CA

- "Camp Paradise" along the San Lorenzo River
 - 30 residents (in 2001)
 - Homeless cleaned up trash in the area
 - Set up a vegetable garden, goldfish pond and bike repair shop
 - Violated municipal ordinance banning sleeping outside from 11pm to 8:30am
- Washed away in a flood

Colorado Springs, CO

- 600 camped along creek beds every night
- City passed a "No Camping" ordinance
 - Bans the homeless from sleeping on sidewalks or public lands within the city limits.
- Homeless moved into motels as part of transitional programs
 - Strict rules (i.e. look for jobs)
- □ Still 100-150 camping
- Long term solution: more low-income housing

Sanctioned Tent Cities



Nashville, TN

- Estimated 4,000 homeless and 765 shelter beds
- City and non-profits servicing a tent city
 - Portable toilets
 - Trash pickup
 - Mobile medical van
 - Visits from social workers
 - Firewood
- Goal is to build permanent shelters and low-income housing

Ventura, CA

- No year-round homeless shelter
- River Haven Homeless Camp
 - Legal, self-governing, transitional camp
 - Space for 25 people
 - Stay for 2 years while looking for a regular source of income and permanent housing
 - \$250/month rent
 - Camp host supervises for 20 hours/week
 - Funded through City and NGOs (Turning Point)
- Long-term solution: more low-income housing

Sacramento

- 2,800 homeless in Sacramento County (2008)
 - 1,194 unsheltered
- "Sacramento Steps Forward" initiative (headed by the mayor)
 - 10 Year Plan to End Chronic Homelessness (Fall 2006)
 - Establish and fund 2,400 housing units over three years
- □ Tent City in the American River Parkway
 - Recently removed by City
 - Safe Ground Sacramento Sanctioned Tent City
 - 64 person encampment

Relocation Programs



City of Chico, CA

- Homeless Evaluation Liaison Program (H.E.L.P)
 - Helps homeless who wish to return to their family/support group
 - Officer will contact the family/support group and determine if they're willing to place this person
 - A one-way bus ticket
- Funding
 - Originally through Police Department
 - Currently through donations
 - North Valley Community Foundation (<u>www.nvcf.org</u>)

New York City, NY

- □ Project Homeless Reconnect
 - Assisted 564 families at \$218/person to-date
 - One-way plane ticket to return to family
 - Certified letter from family

Waste Management



Colorado Springs, CO

- Monument & Fountain Creeks impaired due to E. coli
 - 13 Buckets of human waste
 - Trash and debris along and in creeks
- Real Estate Agent filed a complaint with the USEPA
- Short term solution for human waste
 - Portable toilets privately funded

Summary

- \$100's of millions spent each year by taxpayers cleaning up trash and waste from homeless encampments in creeks/beaches
- Circular Problem
 - Cleanup >> Resettlement >> Cleanup
- Need for permanent shelters and relocation services
- Strategies
 - No camping ordinances some success if coupled with outreach and housing/shelters
 - Tent Cities mixed viewpoints, temporary housing
 - Relocation Programs moderate success, but moving the issue to another community?
 - Waste Management Limited success
